Information We Collect

Information you provide directly

You may provide information directly to us in several ways. For example:

- When you register for our software, we may ask you for information such as your name, email address, postal address, zip code, and telephone number.
- When you view our online training videos.
- When you contact us for assistance with our Support Request form, we receive the information you provide in that correspondence and any
 other information that you send to us.

Information we receive automatically when you use our software
